While I grew up in the Yukon, I moved to Red Deer at the age of 16 and graduated from high school here and have proudly called this community home ever since. I am fluent in both English and French. I served as a Civilian Member with the RCMP for 16 years as a dispatcher, with all my service in Red Deer. This experience gave me a deep appreciation for clear communication, calm decision-making, and compassionate leadership. It also strengthens my ability to listen fairly, act without bias, de-escalate conflict, and make accountable decisions under pressure. I have often been told that I am approachable and that people feel comfortable sharing their concerns with me.
